Public Comment: Shirley Smith wanted to express several thank you's to various City departments, Phillips Police Department, Lt Peterson, for help with a situation he assisted with. And with regards to the storm, she wanted to thank the Mayor and the entire City Crew for all their help with the storm/damage.

- 3. Mayor updates: Just informed everyone that we are trying the best we can to get things cleaned up before the 4<sup>th</sup> and bear with us as the City crews continue to work on cleanup. And wanted to Praise
- 4. Clerk updates:
  - a) Discussion/Action regarding potential policy on banners hanging on Elk Lake Park Pavilion. Kosmer informed the council that there has been a request for hanging a banner on the Elk Lake Park Pavilion like Czech Fest does, but she feels we should probably set some standards. Klimowski suggested we have some sort of timeframe and stipulation that the event occur in the Park. Kosmer will reach out to other communities and work with the states banner application to determine some sort of policy for banners on the Pavilion.

Lyn Ludwig, President and Cheryl Moore Secretary (via phone) were in attendance to give a brief update on the EPA Community Change grant as there was no application to review at this point. Ludwig informed the Council that EPA Cleanup personnel from DC has connected them and they will be coming to the area Thursday July 18th. Ludwig expressed her dissatisfaction of the citation she received for the lawn mowing and wanted to express that any communications and invoices/citations be addressed to Price County United Limited. EPA Cleanup grant requires once a city meeting updates. Requesting on ongoing agenda item for an update item. This is what the state is suggesting, but Ludwig is also asking that the EPA Community Change Grant be a running agenda item as well. Ludwig told the council that they are going to be including the Belan/Express Mart Property in the Community Change grant. Lyn did hand out an ad that they would be running in the paper for more input from the Community. Ludwig also wanted to express that the parking lot in the Elk Lake Park is under parts of the grants and contractually they cannot make any sort of transfers since the full property is included in the grants. July 4<sup>th</sup>, 2 hours prior to the parade they will have a walk and talk starting at Gowey and then the first Wednesday in August at 5:30pm

7. Discussion/Action regarding Moose Lodge Project "Flags Across Phillips". Flags honoring veterans or active-duty members being placed along Highway 13: Requested by Phillips Moose Lodge

John Klimowski President of the Moose lodge, and Ted Harvey talked about the Valued Veterans Program. They would like to mix the valued veteran's program and the moose lodge program and honor our veterans. They are looking for a blessing from the City to do this program, Flags across Phillips. Everyone purchases/ makes a donation for the flags. Funds would be split to go Camp Hacket and the veterans group. Flags would be placed the week of Veterans Day; Flags would be stuck in the ground in the right of way. They would just be American flags, north to the south end of town. This is the Moose Lodge's way of giving back to the community and honoring the veterans.

  - DPW: Playground equipment sold at the auction for \$842.50. July 8<sup>th</sup> that will be removed. 7/15 the new equipment will be added. The Chipper is currently needing repair, but the part was unavailable, so Mid-state is currently building the part needed.
  - Water/Sewer: Been busy last month. 10 inches of rain throughout the town. Got the water readings done, been exercising the valves, and locates coming in. Had to bypass the plant into the lake, there was an open manhole on Kimball/Ash Street but they are getting the DNR notified and now the Plant is running pretty well.

Fifield/Ash Street Reconstruction Updates: Justin from Ayres updated the council on the progress of the project, they are to Kimbal/Ash and Victoria gravel is done and weather dependent, might be able to get gravel down on Fifield this week. Rain has caused some delays but so did Xcel replacing the gas lines during the project.
