Committee of the Whole Meeting Minutes February 4th, 2025

Mayor Charles Peterson called the meeting of the Committee of the Whole to order at 5:30 p.m.

Public Comment: Walt Madsen would like the City to take a look at the dog attack ordinance. Couple years ago he had an issue with the landlord next to him when their tenants dog attacked his son and others. He would like the City to strengthen the language to what the definition of an attack is, he believes it would help resolve any future neighborly disputes. Mayor Peterson advised they would review the information.

  - DPW: No big updates just trimming trees and plowing snow.
  - WS: Nothing broke with that cold snap and had no freeze ups, still getting quotes on a new grinder. They had to put in a bar screen, which they need to clean out manually and they have a lot of miscellaneous items coming through to the treatment plant, such as women's underwear, large wipes and a lot of needles. They did a band aid fix on the grinder right now due to the items coming in.

This additional amendment would remove section b but then Clerk Kosmer questioned what would happen to subsection 1 from section b. City Attorney advised Kosmer to reach out to the county and ask them to be confirm if the section 1 under B would a new section b or if it would be section 6 under A, or a subsection under C. ## **Public Safety - Heitkemper**

8. Fire Department updates: Been pretty busy, 16 calls for January, had a house fire on Ash Street, 5 of the 16 calls were back to the house fire on Ash. Thanks to DPW for sanding the streets afterwards. A lot of manhours into that fire. Utilizing some PPE (personal protection equipment) money, they bought ice rescue suits and ropes and should have those this week and then they will be doing some training once they arrive. They do still have a few truck repairs to work through. Had a prebuild meeting last week with Custom for the new fire truck, so hopefully it can go to build soon, looking at completion and delivery June-Aug of 2025.
