Public Comment: Lyn Ludwig spoke on behalf of Price County United Limited. She stated that the EPA Water Technical Assistance sent a work plan that she will be sharing with the Council soon and it should be complete by April. The EPA Clean up will be working on getting oil removed on the Lionite property and also getting the equipment removed. If anyone in the community is interested in the equipment, they should contact her through PCUL's website. Community Change had a meeting today. They are working on community/economic development. Heitkemper asked if there was anything she could share regarding the properties she's been purchasing as he has been asked that question by the public. She stated that in 2025 she would like to see new use of the properties and property transfers. For example, Gowey is out of their old property and into their new property in January. She would like to see the community involved as they don't want to see them vacant. She is still pursuing the Brownsfield Grant for Express Mart. She stated that the City will be receiving a lease agreement for the parking lot across from Lionite. The Mayor stated that the City would like to purchase the land.
