# 5. Committee Reports:

Ambulance: Been busy, up to 64 calls year to date, their service is going through a lot of the flu bugs and short on staff but able to respond to all the calls and just keep plugging away and have a very dedicated crew.

Library: Applied for a grant to replace the front door to an automatic door through the library association, should be hearing shortly if we received that. The board looked very closely at their library card policy for minors and they have set up different parameters

of children under 16 having library cards, first level is no restrictions, second level is any material except and then you can list exceptions, and third level is permission to just check out material in the children's section. Library Board member Jennifer Markle did a lot of research on this, and this seems to be a good compromise. The library does have a copy of the library card policy for children under 16 and they will advertise that. Urged council to get library cards because it helps with the numbers that effect Library funding for circulation.

Chamber: The new executive director gave her resignation effective immediately, Corey Weiland was the assistant executive director had resigned but she is going to stay on but just as staff not with the assistant executive director title. They will be advertising for a new executive director. Winterfest went very well and was well attended. The visitor guide is out and the enjoy price county is still being worked on and the new Chamber website is up. The Chamber has questions regarding responsibility regarding chamber building maintenance, Kosmer will look into this and provide an update with the findings.

- 6. Phillips Industrial Development Corp (IDC) Update: Meeting last Wednesday, board gave permission to establish a 501c3 for a nonprofit development group. IDC is going to be looking at updating/establishing their website. There is an employee at Price Electric that has a drone, and they have offered to help talk to some videos and photos for their website and they have established an IDC website committee.
