## **DISCUSSION-ACTION ITEMS:**

1. Discussion/Action regarding Price County United Limited's lease proposal for the Elk Lake Park parking lot.

Elliott thanked PCUL and informed them that after reviewing we will not be doing the lease proposal; it is not within our budget or the City's best interest. We have 3 different options we could move forward with that Elliott provided to PCUL. Option 1 we buy it for fair market value, release PCUL of liability and keep it available for public use. Option 2 we can swap the land for another property Ludwig was interested in. Option 3 if there is something in the grants PCUL has applied for that they must retain ownership than the City would be willing to do 99-year lease for \$0, and allow for an indemnification clause. PCUL rejected all the offers and stated that they want to make sure the community and the city becomes partners with our organization and we are all part of this team to make the development happen and it is going to take some effort, and that partnership with the City need to be monetary and it has to be a lease because of the liability, they are a nonprofit doing a ton of work for the community and the lease proceeds will go towards that community, so the City needs figure out how to pay it. PCUL suggested if the City isn't willing to do the full \$180,000 they could utilize multiple partners, have the City be responsible for \$60,000, have the county pay \$60,000 and the remaining \$60,000 could be paid by the major businesses in the area. Ludwig proposed that she would create a letter to the businesses

Other council members asked questions about the path of the property and who determines the future uses and Mark Brzeskiewicz emphasized that the City are not developers and there are other ways the City can partner with assisting with different applicable grants but The City cannot do what PCUL is asking for and it's a nonstarter, some points are very valid, but it is not enough, and there is no guarantee for this money coming back to use. The council advised that businesses are slowing down right now and then to ask them to pay their taxes and pitch in towards the \$60,000 for the lease is a tough ask and questioned if the businesses wouldn't be better off partnering directly with PCUL. PCUL expressed that they really need partnerships right now and informed the council of a meeting on March 6<sup>th</sup> at BW University on Cty Rd F at 6:00pm.
