Public Comment: David Lontcoski reported that the fire department back up engine has been red tagged; it didn't pass inspection and needs some break repair, working on getting that repair.

Ludwig questioned if we explored the EPA Water Technical assistance for the looping project being discussed later. Ludwig spoke regarding the lease with Price County United Limited (PCUL) property at the Elk Lake Parking lot, she stated that PCUL is trying to lift up the entire community as fast as possible to get this project done, this is why they are asking for the money and the lease is about investing in the community. As far as communication is concerned, she wants to get to a Phillips planning commission to discuss the lease more.

- 9. Discussion/Action regarding Elk Lake Park Parking lot section owned by Price County United Limited. Mayor Blake Pluemer asked if there was a planning commission that they can speak to about the lease, Mayor Peterson explained that they would be making a recommendation to City anyways and the Council has already made action on this matter. PCUL stated there is a lot to be gained and a lot to be lost without this development they need to keep this conversation moving. Mayor Peterson started after 2026 there are TIF districts that may help with developments, but we don't have that at this time. PCUL explained that property and lease was a way to prompt conversation about redevelopment and they are looking for representation in a group, there are a lot of creative solutions, and we need to have an open conversation about solutions. PCUL is requesting to set up a meeting within the next 3 weeks with the planning commission so we can get a little deeper into the conversation to get this on a path. Ludwig stated the lease is for PCUL to create a developed property; in order to do that they are looking for funds as they we need to act quickly when grants come up and they really need the community to engage with them. PCUL urged to think out of the box, have to get partners together so we can spin these grants off, they need a planning commission to speak with to ask what we can bring to the game and the City can do. Stephan/ Klimowski moved to seek eminent domain for the .08 acres at the Elk Lake Park Parking lot. Clark – aye, Heitkemper – absent, Stephan – aye, Elliott – aye, Klimowski - ave. Motion Carried

Brzeskiewicz wanted emphasize and to talk about what the City can't do, we can't pay 8.5% of our budget to pay for these lease, let's discuss what we can do to help, we can help with grants and once the TIF's are open, we can help that way.

Stephan – utilizing the parking lot is a way to get people involved is not helping but if we take that off the table then we can talk more about helping in other ways.

The City's offer of those 3 options still stands and they can do that at any point.

Purchase the lot at fair market, Swap land or enter into a long-term 99 year lease for no cost.

Library: Doing good, looking towards summer, did get the grant for the automatic door,

the project needs to be completed by October of 2026.

Chamber: Up to 207 members, had 1 interview today for the executive director, questioned if there is a set curfew for the pavilion, which there is not for adults but no overnight camping.

The Phillips Area Development LTD in the process of starting bylaws and recruit some officers, so things are moving along with that group.
