- LaChance/ Tomaszewski moved to call the Public Hearing to order:

Requestor: Price County Mini Storage

Address: Tax ID 25162: PHILLIPS LOT 11 BLK 24 & PRT OF LINDEN ST Purpose: Request a conditional use permit to construct a 34'X130' building for self-storage units. The building will consist of 10'X24' units and 10'X10' units. The Huycke's, who own land adjacent to the property, sent in a letter regarding their concerns of poor property maintenance at the existing buildings and that they would presume the same level of care at the new buildings. Richard Heitkemper spoke on behalf of the Price County Mini Storage about the development of the properties since they have purchased them and explained the reasoning behind the poor lawn and trimming maintenance since the gentlemen they had doing that work became ill but when they found out about it they went to take care of the property. Another nearby property owner, Marty Stephan, voiced his concerns regarding the runoff of rainwater on the existing buildings and how it floods his property, thus making it unusable. Lyle Schroeder was in attendance and did not have any issue with the project just was not aware the location based on the legal description. Heitkemper and Stephan did talk a little bit back and forth regarding the runoff and the possibility of putting gutters on the building to help alleviate it, but it was a very wet summer. Ted Kempkes did discuss tabling the matter until the property owners that expressed concerns were in agreeance of the project.
