Purpose: Obtain a conditional use permit at the portion of the fairgrounds located in the City of Phillips Limits to create a campground at the property.

Darin Baratka was in attendance via phone to answer any questions and explain the desires of Price County Productions. This is the first step needed to be able to apply for a campground license through the DNR. They would like this to be a campground not for permanent sites but almost like an overflow campground when events are not going on and would at some point like to use the barn to allow for a horse hotel for people traveling for rodeos. The application for the campground through the State has many requirements regarding electrical, bathrooms and site distance so all those will be followed and would ultimately need to be approved by the DNR. There was discussion on the ownership of the land, land is still currently owned by the County as there are several contingencies needing to be met by both parties before the transfer will be complete. There was also much discussion on the current uses of the fairgrounds by the different organizations. Nick Trimner from Price County was in attendance to clarify those questions and ensure that there are leases in place to allow for the existing events to occur and use the fairgrounds and during the

time of these events Price County Productions will have no camping other than what the events typically have.
